

AN ORDINANCE TO AMEND SECTION 937.11 OF THE CODIFIED ORDINANCES TO REMOVE LANGUAGE REFERENCING THE VILLAGE “LANDFILL” AND “YARD WASTE FACILITY”, AND REPLACE THE SAME WITH “COMPOSTING FACILITY”, AND TO ADD LANGUAGE OUTLINING VILLAGE LEAF PICK UP PROCEDURES.

WHEREAS, the Village of Cedarville has found it necessary to update the language of its Codified Ordinances on occasion to remain relevant, and

WHEREAS, the Village Landfill was closed January 21, 1999, and

WHEREAS, the Ohio EPA in accordance with OAC 3745-27 has designated the Village area used for yard waste collection and processing as a Class IV Composting Facility, therefore

BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF CEDARVILLE, OHIO,

Section One: That Section 937.11 of the Codified Ordinances of the Village of Cedarville be amended to read as follows:

937.11 FEES AND DUMPING RESTRICTIONS FOR THE USE OF THE VILLAGE COMPOSTING FACILITY

(a) Effective February 7, 2022, the Composting Facility will accept the following materials: Leaves, yard and garden material, including vegetation, limbs cut less than 4 feet long and 2 inches in diameter, mulch, small brush or small bushes (including rose, flowering, etc.). Whole trees and bushes will not be accepted. Limbs should be bundled with a biodegradable twine.

(b) In accordance with the material restrictions stated in 937.11(a), the Village will provide, at no cost to residents, yard waste pick up on the first and third Fridays for the months of April through September; and on the first Friday for the months of October through March. All accepted materials should be left as close to the curb as possible without being in the street.

(1) Additionally, at the discretion of the Village Administrator, a weekly village-wide leaf pick up will be provided at no cost to residents during the months of October through December. Leaves must be raked as close to the curb as possible without being in the street.

(c) The rates for dumping at the Village Composting Facility shall be as follows:

(1) Residents:

Less than two (2) bags or cans	No charge
Pickups or more than two bags/cans	\$10.00
Dump Truck	\$30.00

(2) Non-Residents:

Less than two (2) bags or cans	No charge
Pickups or more than two bags/cans	\$20.00
Dump Trucks	\$50.00

- (d) All loads and items to be dumped will be inspected prior to being permitted to be dumped.
 - (e) The hours of dumping shall be restricted and the hours are posted at the Village Administrator's office or by calling the Village Offices.
