

Minutes of Cedarville Village Council

Held July 22, 2019

Council met in regular session on July 22, 2019 with Mayor Pergram presiding. Council members present were Brooks, Chisholm, Dawes, Stancliff, Terrell and Ware. The fiscal officer recorded the minutes.

Minutes: Minutes of the July 8, 2019 meeting were accepted as submitted.

Mayor Pergram:

- Working on a job description for a Parks Director – looking for ways to better use Village facilities:
 - Community Park
 - Massie Creek Fields
 - Village ‘Farm’
- Working on ways to improve the Community – and looking for ideas:
 - Athletics
 - Camping
 - Etc.
- Working on updated employee handbook – employees will be required to acknowledge receipt and that they have read it.
- Street lights – would like DPL to upgrade lights on Rt. 42 and Rt. 72 to LED lights
- Will be attending a census meeting on Wednesday at 2:30
- Trucks continue to drop rocks from their loads in town. Working with quarry and with PD to prevent overloading.
- Street signs – and yellow lines – in town are faded. Looking at possibility of eliminating signs in lieu of painted curbs for no parking areas.
- Tuesday, 8/6 is the “National Night Out” – celebration of First Responders – from 6:00-8:00 at Community Park.

Police Chief Combs:

- Quote from WS Electronics for new microwave antenna: \$4734.01.
- Department has 212 service calls in the last two weeks
- As noted, working with OSP on trucks dropping gravel in town. (OSP amazed at the amount of traffic through the center of town)
- The speed / radar trailer will be temporarily installed in town for start of the University’s semester.
- Signed PSISN agreement with the Sheriff’s office
- Dodge Chargers have recall notices on them – work to be done.
- Working on county engineering for “Trucks Prohibited” signage at Federal and Wilmington Roads.

Village Administrator Furay:

- Church St. being “micro-sealed” this week

- Curb painting to be done – attempting to finish before University starts
- Repairs being made to restrooms at the bike path
