## Minutes of Cedarville Council Held June 26, 2023

Council met in regular session on June 26, 2023 with Mayor John Cody, Jr. presiding. Council members present were Becknell, Brooks, Combs, Dawes, and Ruth. Council member Jones had an excused absence. The Interim Village Administrator recorded the minutes.

Elder Brian Hanson form Grace Baptist Church opened the meeting with the invocation followed by the pledge of allegiance.

Council meeting was then opened.

Minutes: Minutes of the June 12, 2023, regular meeting were approved as presented.

Mayor Cody:

• 911 dispatch-village cannot afford new bill established by the county. Has been meeting with Yellow Springs, Jamestown, and University to establish a combined dispatch center in YS.

- The Village of Yellow Springs is looking for a grant for vehicle chargers and the Village may be able to support their request. Council and Solicitor agreed to signing proposal showing interest.
- Fiscal Officer Rod Johnson has announced his resignation. Mr. Dan Howdyshell has been appointed to replace him. A motion to accept the nomination of Mr. Howdyshell to become the Fiscal Officer effective August 1, 2023 was made by Mr. Brooks with a second from Mr. Dawes. All the council was in favor.

Police Chief Smith:

- 73 calls over the past two weeks the lowest call report since taking position
- Department is two people short- Jason will return after serving Jamestown for one additional week, Foust has been away, Kellum has returned.

Village Administrator Kannedy:

- Movement on previously approved grants for Beans n Cream, Orion, The Garage and Second Act have all had movement.
- Meetings for phase two and three for Opera House renovations have brought new information and need for plan modifications
- There is an open position for a part time Public Works employee
