ORDINANCE NO. 2023-03

AN ORDINANCE TO AMEND SECTIONS 137.03 (c), (c)(1), (c)(2), (c)(3) and (c)(4) OF THE CODIFIED ORDINANCES TO REMOVE SPECIFIC POWERS OF THE VILLAGE ADMINISTRATOR WHICH ARE NO LONGER APPLICABLE.

WHEREAS, the Village of Cedarville has found it necessary to update its Codified Ordinances to remain current with present day circumstances within the Village, and

WHEREAS, the operation of all water and sewer plants and systems were relinquished to Greene County by mutual agreement in 1995, and

WHEREAS, the Village Administrator no longer functions as Plant Superintendent over the water and sewer plants and systems servicing the Village, therefore,

BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF CEDARVILLE, OHIO,

Section One: That Section 137.03 of the Codified Ordinances of the Village of Cedarville be amended as follows to remove the following subsections:

137.03 (c) IS OBSOLETE AND HEREBY DELETED

~~The Village Administrator shall hold the position of Plant Superintendent.~~

(1) IS OBSOLETE AND HEREBY DELETED

~~The Plant Superintendent shall oversee, exercise control of and manage the operation of the Village water and sewer plants and systems. He shall make such tests and reports as are required by Village, County and State regulations. He shall see that the water and sewer plants are operating properly and he shall maintain the plants and related equipment in good repair.~~

(2) IS OBSOLETE AND HEREBY DELETED

~~The Plant Superintendent shall supervise any expansion or improvement project on the water and sewer plants that have been approved by Council.~~

(3) IS OBSOLETE AND HEREBY DELETED

~~The Plant Superintendent shall cooperate and offer such advice as his knowledge and experience warrant in the event of problems in the collection and distribution lines of the water and sewer systems. The responsibility of repair and maintenance of such lines, however, is that of the Village Administrator.~~


(4) IS OBSOLETE AND HEREBY DELETED

~~In the discharge of his duties, the Plant Superintendent shall have the assistance of any Village employee assigned to him.~~


Section Two: That this Ordinance take effect upon the earliest time permitted by law.
